### **Notification - Medicine**

Kudumbashree Broiler Farmers Producer Company Limited invites application from manufacturers of commercial poultry medicines, vaccines and sanitation products to be supplied all over the state. #### **Scope of work**

To supply vaccines, medicines and sanitizing items to Kerala chicken farms under KBFPCCL located in various districts based on the demand and purchase order given by the Producer company. Supply and logistics up to the farm should be carried out by the vendor.

#### **Eligibility criteria**

The company or agency should have a minimum experience of 10 years in poultry integration.

The applicant must be a profit-making organization for the last 10 years.

## **Procedure**

- The firms/agencies should report to the officials / representatives of the company with the duly filled application form and necessary documents. The date and venue will be intimated through email.
- The companies / firms should possess documentary evidences for meeting the qualifying requirements, other conditions and for the evaluation criteria.
- Documents required are mentioned in Annexure A.
- Applications without required documents will be rejected.
- Selected companies shall do a presentation on how to carry out the supply of all the categories of medicines, vaccines and sanitation items enlisted by KBFPCCL in the EOI at the estimated maximum rate of Rs 2.50 per bird.
- The empaneled companies will have to submit the quotations for the supply of all the categories of medicines vaccines and sanitation items enlisted by KBFPCCL in the EOI at the estimated maximum rate of Rs 2.50 per bird.

## **Selection Criteria**

- Appropriate service provider shall be selected on the basis of interview and panel discussion by the designated team for the purpose.
- Based on the presentation and the documents furnished, the individual agencies will be evaluated by a committee.
- KBFPCCL will plan the schedule for the supply of vaccines and medicines.
- Work will be awarded to one of the agencies based on the quotes and the agency should supply the vaccines and medicines as per the company's purchase order.
- If the empaneled agency is not supplying after the receipt of vaccines and medicines purchase order, KBFPCCL has the right to black list the company.
- The payment for the supplied medicines and vaccines will be done only after the verification process by the field supervisor in charge regarding the number, quality and condition of the items supplied.

After the presentation before the evaluation committee qualified companies / firms shall be empaneled for medicine and vaccine supply. The selected agencies will have to execute an agreement with KBFPCCL for medicine and vaccine supply. The KBFPCCL company has the authority to cancel the agreement without notice if the above requirements are not met.
